Priority is given to the applicant who has no prior or less participation in the Erasmus+ KA131 staff mobility program.

Priority is given to the applicant who has more job experience at SU (calculation is made based on year, month and day)

Erasmus+ Special Needs Support:

Erasmus+ encourages the participation of the staff with special needs in the program. Staff with special needs a potential participants whose personal/physical condition, mental state or health condition does not allow them to participate in the project/mobility activity unless there is additional financial support.

Erasmus+ Staff Mobility without Grant (Zero-Grant):

Those staff who would like to participate in the program without a grant need to make an application and their applications need to be evaluated as the others. Those participants with zero grants have to fulfil the rights and obligations of the program.
